21 MAY 2024

WELCOME

- Introduction and welcome to observers: Niki Psarias from Caritas Westminster and Eliza Avgeropoulou from ActivityInfo.
- Minutes of previous meeting approved with no changes.

BHA EVALUATION "LEVERS OF CHANGE"

Hannah Reichardt, consultant, presented on the "levers change" evaluation project including:

- Background/ current context ie. SOWC2023 findings, crises trends, increasing digitalisation.
- Timeframe for evaluation project: April to end July
- Theoretical Framework:
 - o Structure: 'how things get done'
 - o Relationships: 'how elements relate to one another'
 - Inner worlds: 'how we think about things'
- Methodology:
 - o Reviewing key literature, podcasts, articles
 - Speaking with people with a broad range of perspectives
- Some weeks into the project there are two emerging trajectories:
 - CVA as an incomplete project (incremental change)
 - o A renewed purpose & paradigm (transformational change)

TAG comments on the project included:

- Don't put all the focus on cash for reform. The other parts of the humanitarian system also need to change.
- Some CVA basics are also not yet done e.g. capacity development. CALP should not stop its learning/ capacity development role.
- The global decrease in funding will affect use of CVA, so the efficiency argument for CVA is important still.
- Give more focus to AI and what it can bring to CVA, its benefits and risks. Can we look at pain points and challenges? This is very different for different actors.
- Can we unpack how the two 'trajectories' complement each other?

WEST AFRICA CASH BANS

Mirko Tommasi, WCAF Regional Rep, gave a presentation on the West Africa CVA bans.

Context:

 Some cash bans were experienced in some countries some years ago and some are still in place in some other countries of the region.

What CALP is doing:

• A Cash ban mapping was launched at the beginning of the year.

- A consultancy will start early June. The main objective is to enable humanitarian actors, particularly in West and Central Africa, to effectively address and mitigate the risk of cash bans. The consultancy will ask:
 - 1. How can we mitigate the risk of having more cash bans issued in other regions/countries?
 - 2. How can we adapt CVA programs in the context of a new cash ban?

How can we mitigate the risk of more cash bans?

- More and better communication with Governments is needed
- Training of Government officials
- Sharing of information
- Better coordination with Governments on the CWGs
- More links between humanitarian CVA and social protection
- Anticipation
- Cash ban adaptation of programmes

PRIVATE SECTOR ENGAGEMENT APPROACHES

Rory Crew, Technical Advisor, presented on CALP's approach to engaging with the private sector.

CALP's current approach:

- Convening: bilaterally and multilaterally
- Information sharing
- Workshops to align humanitarian challenges with private sector products
- Interlocuter/translator
- Research

Considered in future:

- Conference collaborations
- Co-financing specific activities

CALP is re-examining our approach to engaging with the private sector by asking:

- What frameworks and guidance exist to inform inter-sectoral Private Sector Engagement (PSE) strategies?
- What inter-sectoral PSE activities have you seen that are particularly successful/not successful?
- How does CALP ensure a Locally Led Response to PSE?

TAG comments:

- OCHA has a 'Connecting Businesses Initiative' for CVA <u>https://www.connectingbusiness.org/about.</u> CALP should also explore the Private Sector Humanitarian Alliance, as well as other open fora such as those established after the Turkiye earthquake.
- BHA and CRS have PSE frameworks/policies. These are not cash-specific.
- Crown Commercial Service in the UK is a good model for bridging the gap between public/private actors. CCS creates frameworks for working with local and national government in the UK. It might be difficult to reconcile the drive for more locally led endeavour with the idea of centralised systems.
